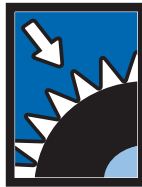

AT A GLANCE

Aqua-Pure[®] Models ICE160-S and ICE165-S single-cartridge water filtration systems help provide consistent high-quality water for commercial cubers and flakers by reducing the harmful effects of sediment, chlorine, and scale at flow rates to 3.34 gpm (12.6 lpm). Built-in scale inhibition reduces the ability of calcium and magnesium to precipitate on the evaporator plates as hard scale.

- **ICE160-S** combines chlorine taste and odor reduction with cyst, bacteria and sediment reduction, and helps provide protection from the potentially harmful effects of chlorine corrosion and scale for up to 35,000 gallons (132,489 liters).
- **ICE165-S** combines chlorine taste and odor reduction with sediment reduction for higher turbidity water and helps provide protection from the potentially harmful effects of chlorine corrosion and scale for up to 35,000 gallons (132,489 liters).

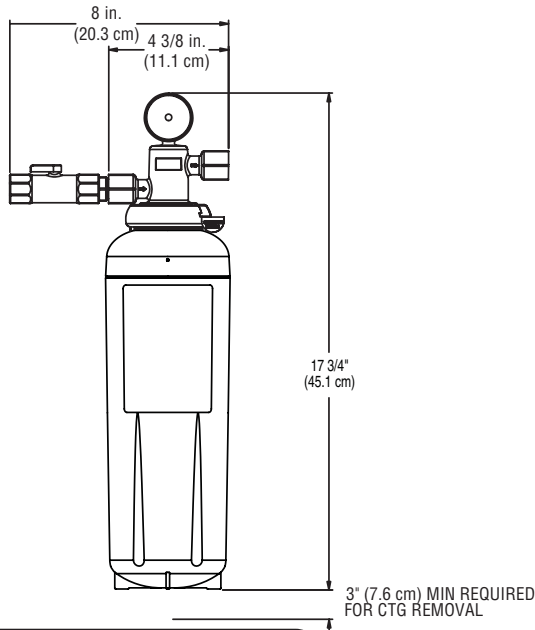

PHYSICAL SPECIFICATIONS



- System includes a head assembly with pressure gauge, inlet-water shutoff valve assembly (comes with 1/2" NPT nipple), mounting bracket, and single cartridge filter.
- Inlet and outlet plumbing connections are 1/2" FNPT.
- Filter cartridges are double o-ring seal type.
- System maximum operating pressure of 125 psi (862 kPa) and operating temperature of 100°F (38°C).
- Recommended service flow rate is up to 3.34 gpm (12.6 lpm).
- Filter cartridges incorporate carbon block media protected by a pleated pre-filter membrane and a scale inhibitor.
- System is NSF Standard 42 and/or CFR-21 compliant.
- Cartridge body is constructed from high-impact glass-filled polypropylene.
- Cartridges are sanitary in design, requiring no contact with the filter media during cartridge change-out.
- Filter cartridges require no pre-activation.
- A NSF Performance Data Sheet (PDS) is included.
- Shipping weight: 4.1 lbs (1.9 kg) per case

IMPORTANT INSTALLATION TIPS

These installation tips are for informational purposes only and are not intended to be used as actual installation instructions. CAUTION: To reduce the risk of property damage due to water leakage, read, follow, and understand the Installation and Use instruction guide BEFORE installation and use of this system.

- Shut off downstream equipment prior to installation of the system.
- Choose mounting location to support full system weight when operating.
- Do not exceed operating parameters for temperature or pressure. System maximum operating pressure of 125 psi (862 kPa) and operating temperature of 100°F (38°C). If pressure exceeds 125 psi, a pressure limiting valve must be installed.
- Do not install outdoors.
- For commercial use only.
- Use on Cold Water Line Only
- Change cartridge at least every six months.
